NOTES

1. The Synagogue's burial scheme is arranged with the Western Charitable Foundation at 32 Great Cumberland Place, London W1H 7DH (tel: 020-7723 9333). The cemetery is located at Bullsmore Lane, Cheshunt, Hertfordshire.
2. Members will not be considered for burial benefits until they have been members for a period of not less than six months.
3. All contributions must be paid in advance. Members thirteen weeks in arrears will be deemed out of benefit.
4. Contributions should be sent to the Secretary by post to the Synagogue with your membership card and a stamped addressed envelope for its return. In order to reduce administration and costs to a reasonable level, members should submit no less than one quarter's contributions.
5. Cheques and postal orders should be made payable to "Walford Road Synagogue". Please do not post cash. Bank standing order facilities are available upon request.
6. Membership rates will be reviewed annually or in the event of a change of rates levied by the Burial Society.
7. On the death of a member with burial rights, the Synagogue will be pleased to provide Shiva chairs and Siddurim for Shiva services on request, but collection from and return to the Synagogue must be arranged by the family. The Synagogue will also provide a minister to take the funeral service if so desired, but attendance at the Shiva or stone setting is a matter for private arrangement.
8. On the death of a member with burial rights, the Burial Society will charge an undertaker's excess fee and Sunday excess fee (where appropriate) and additional fees may be incurred for the overnight care and transportation of a deceased member. These fees are levied by Burial Society directly with the family and are not the responsibility of the Synagogue.
9. On the death of a member, all arrears of contributions must be settled prior to burial.
10. Grave reservations are possible upon payment of the appropriate fee to the Burial Society.
